Ulster University**

Area of Evidence: Module 4 (b) (c) (d) and (h)

Professor Barr is in the School of Nursing and Paramedic Science Faculty of Life & Health Sciences in the Ulster University.

Bingham, David

Area of Evidence: Module 6 (d)

Mr Bingham is a graduate from QUB and holds a Masters of Business Administration. In 1993 he established the HSC Leadership Centre. In 2000 he was appointed Director of Human Resources for the HSC. In 2009 he was appointed as Chief Executive of the Business Support Organisation. He retired from the HSC in 2016 since then working part time as a management consultant for the HSC and others. At the request of the DoH, the Health and Social Care Board and Public Health Agency commissioned a review to examine critically the effectiveness of the Belfast Trust's leadership and governance arrangements in relation to MAH. Professor McClelland was Chairman of Northern Ireland's Review of Mental Health and Learning Disability (2002-2007), the Bamford Review, and subsequently Chairman of the Minister's Board for Mental Health and Learning Disability championing the first phase of the Bamford reforms. He was also a member of the Project Board overseeing the development of new Mental Capacity legislation in Northern Ireland, the Mental Capacity Act (Northern Ireland) 2016.

Professor McConkey graduated with a Bachelor's degree in psychology at Queen's University Belfast in 1970, and undertook Doctoral studies at the newly opened Hester Adrian Research Centre at the University of Manchester devoted to psychological and social research into 'mental handicap'. Professor McConkey's professional career has been rooted in service improvement and innovations.
